

- 3) That where the land is situated within the jurisdiction of a development act-1979 the permission is issued without prejudice to the provision of the said act.

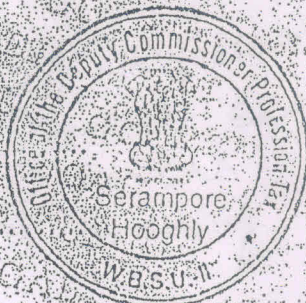
